Letter of Agreement: Organizations interested in any TADA! materials are required to obtain a Letter of Agreement. TADA! does not grant verbal approvals. A Letter of Agreement must be obtained four weeks before the first scheduled rehearsal. Upon completion of this licensing form, TADA! will send you a Letter of Agreement that must be signed and returned in order to receive scripts/scores.

Royalty & Rental Fees: The royalty fee for each musical production is \$60 and a \$40 charge for each performance. The royalty fee for each play is \$30 with a \$20 charge for each performance. Scripts are \$5 for each script and \$15 per piano/vocal score. If we will be shipping 20 or more copies of the script to you, we ask that you please add \$15 to your total for shipping. You are permitted to make the necessary amount of copies of our materials, but –as our contract indicates—you must destroy the materials after the end of your production.

Payment: If paying by check, please mail this form with your payment. Please make checks/money orders payable to TADA!. TADA! charges an additional \$3 for processing fees if paying by credit card.
